Subject: - Extension of Provisional Up-gradation of school upto Sr. Secondary level (Arts, Commerce & Science Stream) upto 2019-20.


Sir/Madam,

I am directed to convey the approval of Competent Authority to grant extension of Provisional Up-gradation upto Sr. Secondary level with Arts, Commerce & Science Stream upto 2019-20 with the following terms & conditions:-

- i). Submit the Building Completion Certificate from competent authority & also fresh SSC.
- ii). Not run any class in unauthorized construction rooms/unapproved structure situated adjacent to power substation.
- iii). School shall gradually reduce the enrolment of the students to accommodate the students as per the sanctioned building plan/availability of class rooms.
- iv). School shall ensure about safety and security of the students studying in the school & submit an undertaking to this effect also.
- v). That school shall pay salary and other admissible allowances to its teaching and non-teaching staff as per on-going CPC through Bank/RTGS.
- vi). The school shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and direction/instruction/guidelines issued by the department from time to time and pronouncement w.r.t. maintenance/utilization of school funds.
- vii). The school shall comply with the provisions of Rules 176, 177, 18(5), 17 (3) & order dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 & 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE from time to time.

- viii). The school shall comply with the order dated 07.11.2017/guidelines of DoE and judicial pronouncements w.r.t. safety & security of the school children and take all steps in this regard.
- ix). Compliance of other conditions as mentioned in provisional recognition/provisional up-gradation granted to the school

Further, the school shall not take admission in Science Stream from current academic session i.e.2019-20 in 11th class and also shift labs from unapproved structure to suitable approved rooms immediately.
